



WHAT IS COVID-19?

Coronavirus disease 2019 (COVID-19) is a respiratory illness that can spread from person to person. Patients with COVID-19 have experienced mild to severe respiratory illness, including fever, cough, and shortness of breath. The virus that causes COVID-19 is a novel (new) coronavirus. It is not the same as other types of coronaviruses that commonly circulate among people and cause mild illness, like the common cold.

HOW DOES COVID-19 SPREAD?

The virus that causes COVID-19 is thought to spread mainly from person-to-person, between people who are in close contact with one another (within about 6 feet) through respiratory droplets when an infected person coughs or sneezes. It may be possible that a person can get COVID-19 by touching a surface or object that has the virus on it and then touching their own mouth, nose, or possibly their eyes, but this is not thought to be the main way the virus spreads.

PATIENTS WITH POSITIVE COVID-19 TEST RESULTS

Patients with confirmed COVID-19 who die and whose death is related to COVID-19 should be immediately reported to the Indiana Department of Health (IDOH) by one of the following:

- 1) NBS Users: Submit a 2019 Novel Coronavirus Morbidity Report in NBS. Mark “Yes” for the “Did the Patient Die from this Illness” field and include a date of death.

- 2) Non-NBS Users: Complete a Confidential Report of Communicable Disease Form. Put “COVID-19” under the Disease and include the death and date of death in the clinical section. Fax completed form to 317-234-2812. Form is available here: <https://forms.in.gov/Download.aspx?id=5082>

Patients with pending COVID-19 test results who die should not be reported to IDOH until the tests are resulted.

- 1) If the test result is positive for COVID-19, report the case through NBS in accordance with current guidance AND follow death reporting guidance above.
- 2) If the test result is negative and the patient is still suspected of having COVID-19 due to the clinical picture, discretion is left to the provider to add a clinical diagnosis of COVID-19.



COVID-19 Guidance for Death Reporting

For Hospitals and Local Health Departments

PATIENTS WITHOUT COVID-19 TEST RESULTS

Patients who die and are suspected of having COVID-19 but were not tested before death should be referred to coroners for reporting.

CERTIFYING CAUSE OF DEATH

Indiana Code requires the physician last in attendance to certify the cause of death and submit to the local health department using the Indiana Death Registration System no later than five days after either initiating the registration process or receiving electronic notification of death from the person in charge of interment. It is important to continue to meet this timeframe so subsequent processes are not delayed due to a lack of death certificate.
